

CONDITIONS OF ENTRY

GENERAL:

1. Information on how to enter the SIXT Rent and Win competition (**Promotion**) and prize details form part of these Terms and Conditions.
2. By participating in the Promotion you will be deemed to have:
 - a) accepted these Terms and Conditions; and
 - b) expressly consented to our use of your personal information under the Privacy Act 1988 (Cth), Spam Act 2003 (Cth), and other related communication and privacy legislation for marketing and other SIXT business purposes.
3. The promoter is Kingmill Pty Limited, trading as SIXT Australia ABN 58 003 966 649 of Level 13, 151 Clarence St, Sydney, NSW 2000.
4. The Promotion commences on 2nd January 2022, 12:00am and entries close on 31st March 2022, 11:59pm AEDST (**Promotional Period**).
5. Entry is only open to New South Wales (**NSW**) and Australian Capital Territory (**ACT**) residents aged 25 years or over with a current valid Driver Licence who are members of National Roads and Motorists' Association Limited (**NRMA**).
6. These Terms and Conditions are governed by the laws of New South Wales, Australia.

How to Enter

7. To enter this Promotion you must during the Promotional Period complete a SIXT rental reservation by:
 - (a) Booking a SIXT rental vehicle and quote the NRMA Membership Number (bookings can be made from 2nd January to end of the Promotion Period); and
 - (b) Picking up the vehicle from and returning that vehicle to an Australian SIXT location.
8. You also acknowledge that at the time of entering the Promotion, your contact details associated with your NRMA membership are current.
9. There will be one (1) component to this promotion: Major Prize Component (game of chance); and skill plays no part in the component. The Promoter's decision is final and no correspondence will be entered into with entrants. Only (1) entry is permitted per rental.
10. All entries, once submitted, become the property of the Promoter.

Major Prize Draw Component

11. This component of the promotion is also a game of chance and skill plays no part in determining the major prize draw winner.

12. There will be one (1) random major prize draw conducted during the Promotional Period (“Major Prize Draw”). All entries received during 2nd January, 2022, 12:00am and 31st March, 2022, 11:59pm will be eligible for the major prize draw. The Major Prize Draw will take place at NRMA, Level 13, 151 Clarence Street, Sydney NSW 2000 at 4th April 2022, 3:00pm AEST.

The first valid entry drawn from the total number of entries received, will win an electric vehicle rental up to the value of \$1,500 (which is subject to vehicle availability at selected locations), and NRMA Holiday Parks and Resorts gift voucher to the value of up to \$1,000. If any prize (or part of any prize) is unavailable, the Promoter reserves the right to substitute the prize (or part of the prize) with a prize of equal value or specification, subject to any written directions given by the appropriate State or Territory Lottery Departments. No responsibility or liability is accepted for any variation in the value of the prizes. The prize is valued in Australian dollars.
16. Total prize pool value for the Major Prize Draw Component is \$2,500.
17. In the event of war, terrorism, state of emergency or disaster, the Promoter reserves the right to cancel, terminate, modify or suspend the promotion, subject to any written directions from a relevant regulatory authority.

This clause does not affect any rights a consumer may have which are unable to be excluded under Australian Consumer law. To the fullest extent
